We, the undersign, hereby like to express our willingness and real interest to use your forthcoming floating armory with the standard facilities and price policy as shown below, under a mutually agreed contract which will be evaluated and will be signed as soon as your good ship is available to provide us the hereunder described services.

It is understood that your forthcoming floating armory will be legal licensed and legal act under the International rules for floating armories/weapons storage and will be legal located Anchorage or OPL Muscat/Oman or OPL Fujairah or in any other location in the Red Sea (prior of 17N), subject to your final decision.

Floating Armory Standard Facilities / Price Policy

- The storage facility for arms and security equipment will be for more than 500 sets, stowed in a safe and air conditioned secured stores.
- Each MARSEC company will have an own storage space
- Ship's accommodation will be for 300 persons in 2, 3 and 4 berths cabins (with private facilities and 24hrs hot water)
- Accommodation will be all the time clean, comfortable with good hygiene and hotel standards
- Heat and Air-condition will be available on a 24Hrs basis and in all cabins and public areas
- Guests will have three meals of good food, taking into account the various nationalities
- Medical facility and Doctor available onboard
- Public places, Saloon(s), Restaurant(s), Cinema, Cafeteria(s), Entertainment room(s) available to all guests
- Gym with standard equipment available to all guests
- Laundry Room with Laundry facilities and dry room available to all guests
- Internet and Email access (Wifi) with facilities in all public areas, available to all guests
- Cable and Satellite TV, Video movies, Video on demand (in all public areas)
- Computer and business room with PCs - Scanners - Printers available to all guests
- Library with Greek, English and other books available to all guests
- Meeting room(s), Classroom(s) and Training rooms with electronic facilities available to all guests
- On board free and/or low cost certified training courses for the MARSEC personnel through certified trainers
- Possibility for installing a shooting simulator (pending evaluation by our lawyers)
- Full safety for crew and guests on board through armed security personnel (24h) / Rules of conduct

If the same arms/equipment is stored onboard more than 90 days, the daily rate will be increased to US\$ 40.00 per set / per day.

(B) The above Accommodation charges will be for the first 15 days from the day of the embarkation of the team. If the team remains onboard more than 15 days then the daily rate will be reduced to US\$ 25 per person/per day.

If MARSEC Company requests to move team only - with our own means - from our floating armory to another floating armory, the cost of such service is calculated to US\$ 150 per person.
